FOR THE CONSTRUCTION OF two monitor wells located near Well HP-9 on the Marine Corps Base in Onslow County, in accordance with the application dated May 26, 1987, and in conformity with specifications and supporting data, all of which are filed with the Department of Natural Resources and Community Development and are considered a part of this Permit.

This Permit is for well construction only, and does not waive any provisions or requirements of the Water Use Act of 1967, or any other applicable laws or regulations.

Construction of a well under this Permit shall be in compliance with the North Carolina Well Construction Regulations and Standards, and any other laws and regulations pertaining to well construction.

This Permit will be effective from the date of its issuance until December 2, 1987, and shall be subject to other specified conditions, limitations, or exceptions as follows:

1. The wells shall be located and constructed as shown on the attachments submitted as part of the permit application.
