This Permit is for well construction only, and does not waive any provisions or requirements of the Water Use Act of 1967, or any other applicable laws or regulations.



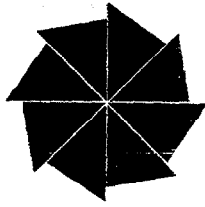
