Substances and Disease Registry, U.S. Public Health Service, Department
of Health and Human Services, Atlanta Georgia 30333

In view of the inclusion of the Camp Lejeune military reservation on
the EPA National Priority List and subsequent listing as a Superfund
area, the Agency for Toxic Substances and Disease Registry (ATSDR)
has compiled the public health assessment noted as reference (a)
and a comprehensive study, published in August 1998, concerning volatile
organic compounds in the CLNC drinking water system and adverse
pregnancy outcomes at that location.

NAVFACESCOM had the opportunity to review and make comments
on the ATSDR draft of the final release of reference (a) and a
member of your staff, Ms. Katherine Landman, is cited as a
contacted person (#78, page 77 of ref.(a)) I would appreciate
receiving a copy of her comments given on behalf of your command.

Since NAVFACESCOM exercises design and construction oversight
of Naval facilities, including Camp Lejeune, I have some questions that
relate to the contamination issues now under survey nationwide
by ATSDR in cooperative efforts with the Department of the Navy
and the Marine Corps.

- A. Does NAVFACESCOM have "as built" maps of the potable
water distribution system as it existed at mcb, Camp Lejeune during
the period 1965-1987? If so I would like copies of that material.
- B. Does NAVFACESCOM have reliable maps of the CLNC reservation
showing the physical locations of the forty six wells that were

In use at Camp Lejeune until 1965 and how water was distributed internally to the major locations where the well water was blended and treated (chlorine, fluoride, etc.)? If so I desire copies of such maps and a description summary of the blending and treatment process

C. Does NAVFACEUCCOM have "as built" or amended maps of the CLNC water distribution system that served the married officers quarters at Paradise Point?

In the period 1965-1967 was the MOA area served by the Holcomb Boulevard facility or the Hadnot Point Facility? Or a combination of both?

Copies of these distribution system maps are desired.

D. Did NAVFACEUCCOM have any oversight of water monitoring programs at CLNC after system construction, approved by NAVFACEUCCOM, had been completed or as additional facilities were added?

If so, what water quality standards were in place between 1960 and 1970?

E. HRSDR documents note the existence of a program entitled Navy Assessment and Control of Installation Pollutants Program (NACP) which began to function at CLNC in July 1984. There is also mention of an Installation Restoration Program (IRP) that appears to be a military counterpart to civilian superfund site mitigation/remediation.

(1) Who, what naval command operates these programs?

(2) Does EPA set the parameters of mitigation/remediation or does the military make these decisions?

(3) Is NACP the action portion of the IRP?

(4) Does NAVFACEUCCOM have a relationship with either of those programs and if so what is that relationship?

I just looked at NFEC website and did not see the above noted programs still in the environmental program of your command.
