Here are some specific questions that we would like answered during our site visit to Camp LeJeune:

Engineering/Water Department:

We would like to meet with Public Works / Utilities (Water) Department to get copies of the following documents.

1. Water Distribution Sampling Plan which you referenced in your fax to us on July 27, 1993.
2. JTC Lab Reports 1984 - 1987.
3. NCDHS reports dated 31 Jan 85 and 21 June 85. We have only one report from 22 Feb 85 (Tarawa Terrace) as attached.
4. Data reports generated in January 1985 and July 1987 summarizing Round 1 and Round 2 sampling as referenced in Doc No. CLEJ - 00346-3.02-1/17/90.
5. Data referred to in a conversation between Stephen Aoyoma (ATSDR) and Eric Parre (MCBCL), Eric mentioned that all potable wells were sampled in 1992 for VOCs and metals.

Other questions

1. When was HP-630 taken offline? Why was it taken offline? What years was this well in operation?
2. General questions about wells and dates taken offline?
3. What are the building numbers for each of the water treatment plants?
4. Which wells contribute to which systems, how many wells are on each system, and the years over which each well was operational, (especially between 1977 and 1993).

Housing:

1. How many residents are served by each water system?
2. Where do married personnel live? What water system serves each of the married personnel housing areas? How many personnel (and dependents) live in each of the married housing areas?

3. How long, on average, do residents live in the same housing area?
4. Will it be possible to match street address with housing area?
5. I may eventually want housing rosters for selected years for certain parts of the base. Do you keep housing rosters? How far back do you keep housing rosters? Are they computerized? When were they first computerized?

Hospital:

1. Do you have a prenatal care clinic?

If yes,

- a. What types of records do you keep on women who receive prenatal care at your hospital? I need a copy of a blank form?
 - b. How many women does your prenatal care unit serve in a typical year?
In 1984? In 1985?
 - c. What percentage of women who deliver at your hospital are seen for at least one prenatal care visit prior to delivery?
 - d. Do you collect a smoking or alcohol history on women who receive prenatal care at your hospital?
 - e. How far back do you keep records?
 - f. What proportion of your prenatal care patients do not deliver at your hospital because they or their husbands are transferred to another navy base or leave the military before the end of their pregnancy?
2. Do you deliver high risk pregnancies referred from other hospitals? If yes, how many a year on average?
 3. Do you ever refer high risk pregnancies to deliver to other hospitals? If yes, about what percentage of pregnancies would you refer out? What criteria are used to define high risk that would be referred elsewhere?
 4. What types of records do you keep on birth defects diagnosed (1) at birth; (2) within a year of birth?

Site Specific Questions**Site 2 - Former Day Care / Pesticide Area**

- What are the 1993 sampling results from surface soil samples?

Site 28 - Hadnot Point Burn Dump

- Was waste burned in one pit only?
- Soil was used to cover the ashes. Where was this soil from? The surrounding area or from outside the burn dump area?
- How was the fishing pond created? Dug out from the fill or dug before the fill? Aerial photos would help here.
- Stocked fish in the pond come from where and of what species?
