

1. As an amendment to the National Primary Drinking Water Standards, reference (a) establishes a maximum contaminant level (MCL) of 0.10 mg/l for total Trihalomethanes (TTHM), including chloroform, that are introduced into drinking water by the reaction of naturally occurring substances with chlorine in the course of water treatment.
2. Plans to initiate monitoring programs at various naval activities for development of a TTHM data base prior to the scheduled compliance dates were discussed during reference (b). As a result, the U.S. Army Environmental Health Agency (RD-S) Laboratory, Fort McPherson, Georgia, has agreed to perform the TTHM analyses.
3. Reference (c) forwarded information concerning regulation of the subject contaminant. It also indicated that guidance pertaining to the sampling/monitoring program initiation would be provided by this Command. Accordingly, sampling bottles, return address labels, directions on how to take the samples, scheduled sampling frequencies and other pertinent data necessary for program implementation should be received at the activity in September 1980.


